

**Fees**

At Glenelg Health Care we aim to support the community providing high quality medical care. Patient's medicare rebate covers only part of the costs associated with providing care. We are a mixed billing practice, endeavoring to continue to bulk bill children under the age of 16 and those with Pension and DVA gold cards. For those patients who do not hold Pension cards, we pass on the cost of the consultation.

Fees for Telehealth consultations are managed as a face to face consultation with fees being applied. To be eligible for a Telehealth consultation you must have seen the General Practitioner at the clinic within the last 12 months. (Children under 12 months of age are exempt.) If you have not had a face to face consultation in the 12 months prior to a telehealth consultation full fees will be charged. No medicare rebate is available in this scenario. Telehealth consultation payments can be made via debit/credit card over the phone. Medicare rebates are paid directly into the patient's account by medicare within 24-48 hours.

Specialty services will incur extra out of pocket expense. (Enquire with reception for details).
